1. The above-named Members of Committees and Boards shall be appointed for a 2 year term, with the term ending December 31, 2012, except where provincial legislation stipulates otherwise.
2. There shall be no per diems or honorariums paid to Board/Committee Members except where provincial legislation stipulates otherwise.
3. The Mayor is ex-officio to all Committees of Council and in the absence of the appointed Council Member(s), shall have full voting privileges.
4. This By-Law shall be deemed to have come into full force and effect on the date of passing.
